

## Legal news for June 2022

1. On 2<sup>nd</sup> June Supreme Court said that education has become an industry fee prohibitive.
2. On 2<sup>nd</sup> June Supreme Court said that “9k per month is nothing but exploitation” regarding Odisha home guards’ salary.
3. On 3<sup>rd</sup> June 2022 Supreme Court held that Arya Samaj’s marriage certificate is invalid.
4. On 6<sup>th</sup> June 2022 Supreme Court objects to frivolous PIL petitions, ‘luxury litigations’ eating up court time.
5. On 9<sup>th</sup> June 2022, Supreme Court allows present Secretary of the All-India Chess Federation to continue till August 15<sup>th</sup>.
6. On 9<sup>th</sup> June 2022, Fresh pleas were filed in the Supreme Court against 1991 law on religious places.
7. On 9<sup>th</sup> June 2022, Supreme court reserves orders on pleas seeking special stray round of counselling for NEET-PG.
8. On 10<sup>th</sup> June 2022, Madras High Court gets its first woman mace bearer.
9. On 10<sup>th</sup> June 2022, Kerala High court held that teens having sex unaware of POSCO Act and suggests teens should be given awareness.
10. On 14<sup>th</sup> June 2022, over 400 Supreme Court’s verdict were translated until Covid-19 stalled AI project.
11. On 16<sup>th</sup> June 2022, Kerala High Court held that CLAT clearance for applying to the post of Assistant Law Officer is violative of Article 16
12. On 16<sup>th</sup> June 2022, a PIL was filed in Supreme court to sack Delhi Health Minister Satyendra Jain and Maharashtra Cabinet Minister Nawab Malik over alleged money laundering.
13. On 17<sup>th</sup> June 2022, the Madras High Court dismissed a plea filed by S. Nalini and RP Ravichandran, convicts in the Rajiv Gandhi assassination case seeking premature release.
14. On 18<sup>th</sup> June 2022, Centre appoints Justice Ranjana P Desai as Chairperson of Press Council of India.
15. On 20<sup>th</sup> June 2022, Supreme court refuses bail to Nawab Malik and Anil Deshmukh from prison for voting in MLC elections.
16. On 20<sup>th</sup> June 2022, Supreme court stays Bombay High Court order to Bajaj Allianz to compensate 3.5 lakh farmers who suffered losses in rains.
17. On 21<sup>st</sup> June 2022, a PIL was filed in the Supreme court challenging Agnipath Recruitment Scheme for Armed Forces.
18. On 21<sup>st</sup> June 2022, Calcutta High Court seeks State Government’s response on plea seeking CBI probe into Singer KK’s death.
19. On 23<sup>rd</sup> June 2022, Madras High Court conducted mid night hearing restraining AIADMK general council from passing any resolution.
20. On 23<sup>rd</sup> June 2022, Kerala High Court held that person outside India can file anticipatory bail application but before final hearing accused must be in India.
21. On 24<sup>th</sup> June 2022, Supreme Court dismisses Zakia Jafri’s plea against SIT Clean Chit to Narendra Modi in 2002 Gujarat Riots larger conspiracy case.

22. On 27<sup>th</sup> June 2022, Telangana High court seeks stance of the petitioner within the hearing of a writ petition questioning a rule of the Telangana State Judicial Service and Cadre rules 2017.
23. On 27<sup>th</sup> June 2022, PIL in Delhi High Court asks to remove VT on aircrafts name, calls it 'symbol of slavery.'
24. On 28<sup>th</sup> June 2022, Justice Sathish Chandra Sharma takes oath as Chief Justice of Delhi High Court.
25. On 29<sup>th</sup> June 2022, Maharashtra Chief Minister Uddhav Thackrey resigns ahead of floor test.
